Altar: The altar typically accommodates an (one) officiant, (two) a marrying couple and about 4-6 bridesmaids and groomsmen

Key *Self Service Entry*

The key is located in a lock box by the Chapel Cottage rental house (also available for wedding rentals) on the exterior side of the front stair porch railing at ground level. Chapel Cottage is directly to the **left** of the Chapel pathway. The code is emailed to you at time of payment through Stripe platform. **Please read the details for the key code. No deposit refund without the return of the key to the lockbox and both door and windows locked along with the floor swept.**

Chapel “Do’s and Don’ts”

- The Chapel is a **Smoke Free/ Vape Free environment**.
- This includes **no littering cigarette butts** on the ground.
- Sea Oats dune grasses are protected grasses under the Texas Natural Resources Code, specifically Section 63.001, which prohibits the removal or destruction of these plants on coastal beaches. Additionally, sea oats are “protected native plants” Tex. Parks & Wild. Code Ann. § 88.002. See more in the USDA Fact Sheet, USDA, and TPDW Title 5. Wildlife and Plant Conservation. No walking or picking grasses please.
- **No walking off the flagstone paths** permitted under any circumstances. The dune grasses are protected by state law. All photographers and visitors must stay on the flagstone paths. This is all private property and trespass restrictions apply for noncompliance.
- The casement windows at the sides of the front altar, need to be unscrewed by your hand to open – top and bottom. Once open, please tighten back the screw so the windows don’t slam shut. When closing, unscrew them and close and tighten again.
- Parking is to the left of the Chapel Cottage rental cabin on the empty lot parking pad with gravel at 203 S. 11th and E. Ave B.
- Please do not park the lots of our neighbors.
- There is **no hanging or taping or adhering anything to the walls**.
- There is **no hanging anything onto the iron support crossing through the Chapel**.
- Only real flower petals may be thrown outside. Color flower petals stain the altar and floors. **No faux petals, glitter, bird seed or rice**.
- Flowers may be put at the altar or at the ends of the pews.
- **No flames, fire, smoke or burning** for the protection of the art.
- Battery operated candles only.

The parties agree the Chapel and the land are privately owned and only open to third parties by permission from the owners.

I have read and understand the care of the Chapel, its windows, the Dune grasses, smoking, locking up, picking up trash left, etc. and I understand I am responsible for any damages as stated under the Accepting Responsibility portion of the contract.
